



Summer Day Camp Financial Aid

At PEEC, we believe that everyone should have the opportunity to benefit from a summer spent learning in nature. Our Financial Assistance Program offers families financial support with program fees for Summer Day Camp to make our program accessible to as many families as possible.

The Application Process

Each financial aid application is comprised of a completed application form and appropriate documentation, which allows for a fair and objective evaluation of need to guide the awards process.

1. Financial Aid Application Form
 - a. One form is required per family. Please follow the directions carefully and fill in all fields.
2. Income Verification
 - a. Each family must provide a copy of the most recent W2 or tax return for each adult in the household to verify information cited on the application form.

In order to apply financial aid awards to each family's total camp fees, all applicable registrations must be completed within CampBrain. Each registration requires a non-refundable \$50 deposit when submitted. Families are welcome to register at any point in the financial aid application process or wait until notification of awards are made.

Application Review

Applications and all accompanying documents are confidential and will only be reviewed by the PEEC Leadership Team. Award amounts are calculated based on the U.S. Federal Poverty Guidelines. Funds to provide these awards are provided by a variety of private donors.

PEEC evaluates applications at the end of each review period.

Review Period A: December 1st through January 31st

Review Period B: February 1st through March 31st

Review Period C: April 1st through May 15th





While applying within an earlier review period provides a higher likelihood of financial aid funds remaining available, early applicants will not receive larger awards than those who may apply later. Awards are determined using the information provided and a sliding scale based on the U.S. Federal Poverty Guidelines. Financial aid awards can cover up to 50% of the program fee. Applications will not be accepted after May 15th.

Once awards have been determined, applicants will receive an email to share the outcome of their application. Those who qualify for a financial aid award will be provided with the total amount awarded at that time. Families who have already completed registration will be provided with an updated invoice for their total camp fees.

Awards

Accepted awards are automatically applied to each family's CampBrain registrations by PEEC staff. Registrations supported by financial aid awards are subject to all standard policies of PEEC Summer Day Camp registration, including cancellation deadlines and refund policies.

Summer Day Camp Cancellation Policy:

Cancellations submitted in writing before June 1st will receive a refund of all fees paid beyond the deposit. \$50 deposits paid at the time of registration are non-refundable.

Awards may only be applied to up to two weeks of Summer Day Camp per camper. Awards cannot be combined with any other discounts, including Sibling or Early Bird discounts.
